Why?	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefullyto understand what we do.	
What?	The types of personal information we collect and share depend on the product or service you have with us. This information can include:

How?	All financial companies need to share Customers' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their Customers' personal information; the reasons <b>Northern Mortgage</b> chooses to share; and whether you can limit this sharing.

Definitions		
Affiliates	Companies related by common ownership or control. They can be financial and non-financial companies.	
Non-affiliates	Companies not related by common ownership or control. They can be financial and non-financial companies.	
Joint marketing	A formal agreement between non-affiliated financial companies that together market financial products or services to you.  Northern Mortgage does not jointly market.	

## Other important information

**Do Not Call Policy:** This notice is the Northern Mortgage Do Not Call Policy under the Telephone Consumer Protection Act. We do not solicit via telephone numbers listed on the state or federal Do Not Call lists, unless the law allows us to. Northern Mortgage employees and its service provider employees receive training on how to document and process telephone marketing choices. Consumers who ask not to receive telephone solicitations from Northern Mortgage will be placed on the Northern Mortgage Do Not Call list and will not be called in any future campaigns, including those of Northern Mortgage affiliates.
